

Area 15 Delegate Conference Report

This report is on the 64th General Service Conference which took place at the Winchester Hilton Hotel—Rye Brooke, NY. The festivities began on Saturday, April 26 with attendance at the Remote Communities Committee meeting and Southeast Regional Area Dinner. The Conference continued through Saturday, May 3, including an official visit to Stepping Stones and the farewells of three Trustees.

A.A. Spiritual Pamphlet Approved

The <u>Literature Committee</u> recommended and the conference approved the "Many Pathways to Spirituality" pamphlet in one of the most heartfelt discussions of the conference. The pamphlet includes references to the "Great Spirit," God, "Creative Intelligence," Higher Power, "Allah", and the Lord's Prayer, and several short paragraphs about the real world battle tested experience of A.A.s. The Conference approved the revised Circles of Love and Service pamphlet, a correction to the Preface of the Big Book. The Conference also rejected the changes to Living Sober and the Primary Purpose (blue) Card (F-17) that "Nonalcoholics are welcome to attend open meetings as observers."

The **Trustees Committee** approved the slates for the Class A and B Trustees for the General Service, A.A.W.S. and A.A. Grapevine Boards, and the Pacific and Eastern Canada Regions, and the Officers of the General Service Board.

Circle and Triangle With Recovery, Unity and Service—Not Now

The <u>Literature Committee</u> discussed, but took no action on the request to consider the use of the Circle and Triangle as an unofficial Service Mark on Conference approved literature. The Committee, however, did not discuss the difference between a Trademark, a Registered Mark and a Service Mark. At the closing lunch, one of the Class A Trustees stated he believed the General Service Board would look at the use of the Circle and Triangle with the Three Legacies in it at their Board meetings given the interest of the Fellowship in it.



The Committee also did not approve a mental illness pamphlet despite vigorous debate and minority opinions. The Board member indicated this may be revisited by the Board as well.

Markings on a Journey Updated



The Finance Committee felt the Areas contributions for the Delegates' GSC expenses did not need to be increased even though the approximate cost is around \$4,000 per Delegate.




Groups and Attendance Sheets

Develop Plan to Translate Background Material Into French and Spanish

The Finance Committee recommended that GSO develop a plan to translate the GSC **Background Material into French and Span**ish. It was also discussed that GSO coordinate volunteer Areas to translate 50 pages or so each and send them to GSO to compile and distribute.



GENERAL SERVICE OFFICE FINANCES

OVERALL GSO, AAWS, AA GRAPEVINE INC.

Before we get to the actual figures, some interesting financial information. The cost per group is \$146.96, the cost per member was \$6.84, and the cost of services NOT covered by contributions is \$1.87 per member per year. Also, a 1.00 in 1945 has the buying power of \$13.00 in 2014, or 8 cents in 2014 would buy a \$1.00 worth of stuff in 1945.

GSO had net income of \$204,215, while revenues and expenses were up by over \$500,000. Net sales were \$12,604,719. Contributions of \$6,906,371, included the highest amount of contributions ever in one month in December. These sums came from 42.5% of the 64,694 groups listed with GSO about the same as last year.



The Grapevine had a net profit of \$315,205, with most of it coming from "Other Publishing Income." Magazine Income decreased by \$100,547.

La VINA

La Vina lost \$142,544 in 2013, after a loss of \$115,820 in 2012, and \$69,723 in 2011.


RESERVE FUND

The Reserve Fund balance of \$15,301,653 covers approximately 10.9 months of operating expenses. GSO paid \$7.7 million into the Pension Fund in the beginning of this year, after earning \$3,564,880 from investments. The Pension Fund still owes \$3.6 million for "Pension Benefits," and \$3 million for the "Post Retirement Medical Fund." This leaves us in a much better position than in 2012 when we owed around \$14 million total to both.

Grapevine Review of La Vina



The Grapevine Committee approved the A.A. Grapevine board's suggestion to create a new business plan for LaVina for the 2015 Conference, and the Right of Decision of the GV Board on formatting decisions, but the GSC voted it down. La Vina had 10,145 subscriptions, almost

1,000 more than 2012. Most of the increase came from around 900 subscriptions purchased by a Hispanic Convention in California.



Grapevine Circulation Down Again

A.A. Grapevine, Inc. reported the average monthly subscriptions for Grapevine were down to 77,126 from 83,258 in 2012. That is a loss of 6,132 monthly subscriptions. The Grapevine also had 5,535 online subscriptions for the year. The Grapevine Committee reviewed the "Alcoholism at Large" pages, but they took no action.
